	Answer: The Company will increase the current levels of cash used in operating activities with exploration programs planned across its projects.	
2.	Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
	Answer: On 13 October 2020 the Company announced that it had received firm commitments from professional and sophisticated investors to subscribe for 100,000,000 new fully paid ordinary shares in the Company at an issue price of \$0.01 per share to raise \$1 million (before costs), subject to shareholder approval at the upcoming AGM to be held on 25 November 2020. On 19 November 2020 the Company offered eligible shareholders the opportunity to participate in a share purchase plan (SPP) to raise a further \$1 million (before costs). The SPP is expected to close on Monday 2 November 2020 (subject to change).	
3.	Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?	

Answer: Yes, for the reasons provided in 1 & 2 above. The Company is continuing with essential exploration expenditure and is assessing its opportunities to maximise the value of the Company's existing assets and opportunities.
